Potential Health Effects (Acute and Chronic):

Effects may be delayed.

Inhalation:

High vapor concentrations may cause drowsiness. May cause respiratory tract irritation. Low hazard for normal industrial handling. May cause kidney damage. Material has a very low vapor pressure at room temperature, so inhalation exposures are not expected unless material is heated or misted. The toxicological properties of this substance have not been fully investigated. Effects may be delayed. Inhalation of fumes may cause metal fume fever, which is characterized by flu-like symptoms with metallic taste, fever, chills, cough, weakness, chest pain, muscle pain and increased white blood cell count. Can produce delayed pulmonary edema. Zinc oxide dust is considered to be of low toxicity and is classified as a nuisance particulate by the ACGIH. However, inhalation fumes or very fine dust may causes "zinc fume fever", which is characterized by flu-like symptoms with metallic taste, coughing, weakness, fatigue, muscular pain, and nausea, followed by fever and chills. Onset of symptoms occurs about 4-12 hours after.

Skin Contact:

Continued absorption may cause kidney damage. A single prolonged skin exposure is not likely to result in the material being absorbed in harmful amounts. Prolonged or widespread skin contact may result in the material being absorbed in harmful amounts. Causes skin irritation.

May be harmful by inhalation, ingestion, or skin absorption. Vapor or mist is irritating to the eyes, mucous membranes, and upper respiratory tract. Prolonged and/or repeated contact may cause irritation and/or dermatitis.

Eye Contact:

Causes eye irritation. Dust may cause mechanical irritation.

Ingestion:

May cause gastrointestinal irritation with nausea, vomiting and diarrhea. May cause kidney damage. May cause central nervous system depression. May cause irritation of the digestive tract. 4. First Aid Measures

Emergency and First Aid

Procedures:


